Scene of Crime Officers (SOCOs), in Karnataka are deployed by the Karnataka State Police to assist in the professional examination of crime scenes, including securing the scene, identifying, documenting, collecting, preserving, packing, and labeling physical evidence Scene of Crime Officers are a vital support agency for the Police department, having been recruited for the first time in the country by the State of Karnataka in 2021-22 with the objective of enhancing the quality of investigations under the department of the Directorate of Forensic Science Laboratory. Their role is very crucial inforensic investigations, assisting investigating officers in examining crime scenes and gathering evidence which includes protecting the crime scene and collecting evidence according to established standard operating procedures. This approach contributes significantly to building cases based on physical evidence gathered from crime scenes. There has been an emphasis on raising awareness among Police personnel about the importance and necessity of scene of crime officers, as well as their role and cooperation within every police station. The response from police personnel has been overwhelmingly positive, indicating a strong recognition of the value that Scene of Crime Officers bring to the investigative process.

The effective investigation of crimes relies significantly on the collaborative efforts of various professionals within the criminal justice system. Among these professionals, Scene of Crime Officers play a crucial role in identifying, collecting, and preserving evidence from crime scenes. Their work is vital for maintaining the integrity of forensic evidence, which is essential for solving crimes and achieving successful judicial outcomes [1]. Despite their important contributions, the perception of Scene of Crime Officers among other law enforcement personnel, particularly police officers, is a matter of interest. For this research, Police personnel have been surveyed as respondents and asked a few key questions.

This paper examines police perceptions on Scene of Crime Officers and their roles in crime investigations, highlighting the implications for inter-professional collaboration, procedural efficiency, and overall investigative success. By exploring this dynamic, the study aims to deepen our understanding of the challenges and opportunities for enhancing crime scene management practices within the criminal justice system. In this paper, we explore the opinions of police officers holding the ranks of CPI/PI, PSI, ASI, and CHC. These opinions serve as the primary focus of our discussion, helping us to examine the role of the Scene of Crime Officers and their importance at crime scenes. A total of 35 Police personnel participated and gave valuable input.

However, Scene of Crime Officers often face challenges in their operational environment, especially when navigating complex relationships with police officers, whose understanding of the CSO role can vary significantly.

Another notable work identified is that Police and CSO Collaboration in Investigations Effective collaboration between police officers and Civil Society Organizations (Scene of Crime Officers) is crucial for conducting seamless investigations. highlight the interdependence between police first responders and forensic specialists, noting that miscommunication or lack of coordination at the crime scene can compromise evidence [4]. This study further examines how differing perceptions of authority and expertise affect the dynamics between police officers and Scene of Crime Officers.

Officers work closely with police officers, detectives and forensic experts. Their ability to communicate findings effectively ensures that investigations are guided by accurate and reliable evidence

Forensic Analysis Support: The evidence gathered by Scene of Crime Officers forms the foundation for forensic analysis. Their expertise in locating and preserving evidence enhances forensic laboratories' ability to provide meaningful insights.

Crime Scene Reconstruction: Using the collected evidence, Scene of Crime Officers often assist in reconstructing the sequence of events, helping investigators understand the circumstances surrounding the crime.

A smaller group of respondents (8%) expressed concerns that Scene of Crime Officers do not follow proper evidence handling and packing procedures. Although this percentage is smaller, it represents a differing perspective that could be influenced by factors such as resource availability, the frequency of serious crimes, or the belief that Scene of Crime Officers may be more beneficial in larger, specialized units rather than at every station. Nevertheless, the overwhelming support for Scene of Crime Officers emphasizes the general belief in their essential role in the investigative process.

### **Findings**

- The high level of awareness among police officers in Belagavi district about the role of Scene of Crime Officers indicates effective training and communication within law enforcement agencies. Over (91%) of police personnel are aware of these officers and their roles in crime investigations, while only (9%) are not aware.
- Data shows a strong consensus on the essential nature of Scene of Crime Officers, with (80%) of respondents either agreeing or strongly agreeing on their necessity. An additional (14%) of police personnel agree, while (6%) remain neutral on this issue. This overwhelming support highlights the crucial role these professionals play in preserving evidence and managing crime scenes effectively.
- A significant majority, (77%), believe that the presence of Scene of Crime Officers greatly alleviates the burden on police officers, while (23%) of respondents disagree.
- Regarding the handling and packaging of evidence, (62%) of respondents believe Scene of Crime Officers perform this task properly. Meanwhile, (8%) say they do not, and (30%) state that it depends on the specific case
- A notable (94%) of respondents say that Scene of Crime Officers cooperate during crime investigations, with

- investigations, with only (6%) of police person nel claiming they do not cooperate.
- Additionally, (86%) believe that Scene of Crime Officers should work at every police station, while (14%) disagree.

#### **Conclusion**

Investigating crimes is not an easy task, especially when an offender is motivated and intentioned. However, the crime scene can reveal the true story of the crime. It is essential for Investigation officers to detect and analyse the crime scene thoroughly. This paper emphasizes the importance of Scene of Crime Officers in the investigation process. Police personnel recognize the value of these specialists, who cooperate during investigations and assist police in gathering crucial evidence. Scene of Crime Officers are trained in the proper handling and packaging of evidence in a scientific manner, which can significantly reduce the workload for police officers. To improve crime investigations, it is recommended that Scene of Crime Officers be recruited at every police station. Generally, police personnel respond positively to the contributions and work ethic of

Scene of Crime Officers. This should be encouraged by other states also keeping the State of Karnataka as a model for the recruitment of SOCO for every police station [6].
